- Westpac may decide to its sole discretion, on any grounds it thinks fit and, without rendering Westpac or Xero liable in any way, to discontinue the provision of Data to Xero pursuant to this Authority by written notice;
- any revocation of this Authority by me/us will not take effect until 48 hours after the written notice of revocation is received by Westpac from me/us;
- Westpac may vary the terms and conditions under which it supplies Data pursuant to this Authority by written notice to me/us;
- the liability (if any) of Westpac and Xero arising from this Authority is several and neither party is jointly liable for any actions, omissions, fraud, or negligence of each other;
- Xero's and Westpac's liability for the breach of any warranty implied by the Consumer Guarantees Act 1993 (if the Data is supplied for the purposes of a business, the Consumer Guarantees Act will not apply) or any relevant legislation in supplying the Data will be, to the extent permitted by law, limited to supplying the services again; or the payment of the cost of having the services provided again, the choice to be at the option of Westpac or Xero as applicable;
- I/we have the power to enter into the arrangement created by this Authority and that all steps necessary for the valid execution of this Authority have been taken.

This Authority is only valid from the date it is received by Westpac and signed by the authorised signatories of the designated bank account/s.
